ORDINANCE

Futher to amend the Uttar Pradesh Commission for Backward Classes Act, 1996

WHERESAS the State Legislature is not in session and the Governor is satisfied that circumstances exist which render in necessary for him to take immediate action;

NOW, THEREFORE, in exercise of the power conferred by clause (1) of Article (1) of the Constitution, the Governor is pleased to promulgate the following Ordinance:-

- 1. This Ordinance may be called the Uttar Praesh Commission for backward Classes (Amendment) Ordinance, 2007.
- 2. In section 3 of the Uttar Pradesh State Commission for backward Classes Act, 1996, hereinafter referred to as the Principle Act, for sub-section (3) the following subsection shall be substituted, namely:-
- "(3) The Commission shall consist of a Chairman, two vice Chairman and seventeen other Member's nominated by the State Government from amongst persons of eminense, ability and integrity:

Provided the sixteen members including the Chairman shall be from amongst the backward classes."

- 3. in section 4 of the Principle Act-
- (a) for sub-section (1 the following sub-section shall be substituted namely:
- "(1) The Chairman, Vice Chairman or every other member shall hold office for a term of one year from the date he assumes office:

Provided that the Chairman, Vice Chairman or other member shall hold office as such during the pleasure of the State Government.

- (b) sub-section(3) shall be omitted
- (c) After sub-section (5) the following sub-section shall be inserted, namely:
- "(6) (a) The Chairman shall be hairing the status of a Minister of the State.
- (b) The Vice Chairman shall be hairig the status of the Deputy Minister of the State;
